Meeting was called to order by Michael Burke at 2:44 P.M.

Financial Report:

Financial report was made declaring the net balance for all accounts to be about \$43000. Revenues of about \$11,000 compared with \$17,000 of expenses.

The net decline of \$6000 from last year was due to capital spent on deferred maintenance and equipment purchases (\$6,000). The other large proportion of LDF expenses were for range fees (\$7,000).

It was declared that we have Equipment with a replacement value of about \$44,000.

Old Business:

State of LDF:

Michael said the state of LDF has grown stronger from the preceding year with increased membership, much better equipment and strong growth in the 3-gun match development.

LGR Venue:

The venue at Alpine has been lost for these past three months due to a stray round hitting someone's house. The final decision about continued shooting of rifle and pistol has yet to be determined by the LGR&G Board. It was said that a solution may be to build an overhead whereby a muzzle will not be able to be directed above the back stop berm. Although the decision by the LGR&G Board has not been made, it is a very doubtful venue for LDF to continue.

New Business:

3-Gun

Craig Evans discussed the 3-gun series match scheduled for April 28. He has asked the membership to come out and see some quality shooters and to help with breaking down the stages and storing the equipment after the match. He said the time to begin with help

would be around 3:00 or 4:00. It is expected to draw about 60 shooters and will have 6 stages.

Pala Range:

It was noted by discussion that the membership would like to develop a third shooting day for the club. Dialogue has started between Paul Freitas and Harold about securing another day for our club at Pala.

Harold has asked that no shooting start before 8:00am.

It was stated that although 2 clubs i.e. Pala Practical Shooters and Reservation Shooting Club define a section that maybe the 3-gun match could serve as a third club for our mission points at USPSA.

Classifiers:

Paul Rumberger raised the issue of needing to schedule regular classifiers. Paul answered that there is a log of classifiers recently used by each club and a plan to determine a set of classifiers preselected for each club in support of this coming year.
